

Conference Registration & Cancellation Policy

Registration for a conference can be done by registering online through the conference registration website or by submitting a signed company Purchase Order to the Stier Group by emailing to conventions@stier-group.com. Unsigned PO will not be accepted.

Payment by credit card will be charged at the time of registration.

Registration by Purchase Order

1. Purchase Order form should be submitted by e-mail: conventions@stier-group.com.
2. Payment by bank transfer must be received within 5 business days from the day of order submission or within 14 days from the date of the conference and / or event, whichever is the earlier.
3. Registration for the conference and / or event by a Purchase Order obligates the registrants/company whether the payment was received by the required date or not. Only the organizers have the right to cancel the registration at any time and without prior notice if payment is not received on time.

Payment by Bank Transfer

1. A copy of the bank transfer must be sent by e-mail to: conventions@stier-group.com within 5 business days from the date of registration and no later than 14 business days before the date of the conference and / or event, whichever is earlier.
2. Bank transfer charges are the responsibility of the participant and should be paid at source in addition to the registration fees.
3. When submitting payment by bank transfer please include; the name of the conference and / or event, the name of the company, the name of the registrant or the number of registrants according to a list of registrants attached to the Purchase Order form.

Cancellation Policy

Refund of registration fees for a conference and / or an event must be submitted in writing and will be processed upon receipt of written notification* by the Stier Group and in accordance with the following cancellation policy:

1. Cancellation can be made within 14 days from the date of registration (unless registration was made during the 7 days prior to the conference and / or the event) shall be subject to a cancellation fee of 5% of the actual ticket price or 100 NIS, whichever is lower, plus service fees.
2. Refunds due to cancellation that took place at times other than above, will be made as follows:
 - a. Cancellation up to 30 days (workdays and rest days) before the conference and / or event, will be charged a cancellation fee of 25% of the total price paid plus service fee.
 - b. Cancellation of up to 14 days (workdays and rest days) before the conference and / or the event, will be charged a cancellation fee of 50% of the actual total price or 100 NIS, whichever is lower, plus service fee.
 - c. Cancellation of less than 14 days (workdays and rest days) before the conference and / or the event will be charged 100% cancellation fee.
3. **The determining date is the date the cancellation notice is received by the organizers.**
4. Written notification must be submitted and include the following details: participant's full name, company name, conference and / or event name, date of the conference / or event, registration confirmation number and payment details. 5. Refunds will be processed within 14 days from the day of receipt of the cancellation notification.

Privacy Policy

1. The organizers may use the information provided by the participants in order to send publications and invitations about conferences, events and exhibitions organized by the Stier Group.
2. The organizers may share participants' information with the conference or event sponsors and/or the conference organizing entities in order to send publications and information.
3. If you marked on the registration form that you do not approve receiving invitations and/or publications for exhibitions and events of Stier Group, you will not be included in this Stier Group's events recipient list and will not receive any more invitations to our exhibitions and events in the future via email and SMS.

Comments:

1. The conference program is subject to changes.
2. A confirmation email will be sent at the end of the registration. Please bring the confirmation with you on the day of the conference.
3. Due to the professional nature of the conference, event and/or exhibition entrance of children under the age of 18 will not be permitted without exceptions.
4. Entry to the exhibition is included in the conference ticket.

5. Admission to the exhibitions and conferences will be permitted in accordance to the Israeli Ministry of Health guidelines on the day of the exhibition or conference.
6. Entrance will be permitted with the presentation of a Green Pass, presentation of a recovery or vaccination certificate, or presentation of a negative corona test.
7. Unvaccinated persons are required to present a negative COVID-19 PCR test result performed within 72 hours before the date of entrance or a confirmation of a negative result for a rapid test performed 24 hours before the date of entry from a testing facility approved by the Ministry of Health.
8. All entrants must present an ID card (ID card, driver's license, passport).
9. Face masks must be worn at all times while indoors (visiting the exhibition or attending a conference)

Change of date or cancellation of the conference / event due to force majeure:

1. **"Force Majeure"** is one of the following situations (Hereinafter **"Force Majeure"**):
 - a. Act of war and/or military operation and / or a situation of active combat between Israel and her neighboring countries and / or terror organization; or
 - b. A situation in which a limitation on the number of people that are allowed in gatherings, congresses and / or exhibitions was imposed; or
 - c. A situation in which an Israeli competent authority has banned the organizers from opening the conference; or
 - d. A situation in which the organizers are unable and / or are not allowed to open the conference due to a medical situation and / or local and / or international epidemic; or
 - e. A situation in which the exhibition and / or conference venue or a part thereof suffers damages that prevent the organizers from operating the conference or event as planned; or
 - f. Any other situation that prevents the organizers from opening the conference and/or event as planned under circumstances that are beyond organizers' control.
2. **Change of conference date due to Force Majeure:** It is clarified that changing the date of the conference or event by the organizers as a result of the existence of a force majeure, including the conference and / or event hours, will not violate the registration agreement and will not constitute a ground for its annulment and will not establish for the participant any ground or claim against the organizers. If the date of the conference and/or event is postponed as stated, the organizers will provide the participant with the opportunity to participate in the conference and / or event at a new date. It is clarified that such a case will not constitute a reason for the participant to cancel his participation in the conference and / or event. If a registrant wishes to cancel his/her participation, the organizers are entitled to the cancellation fee as determined for the date of the conference and / or event at their original date.
3. **Cancellation of the conference and/or event due to Force Majeure:**
 - a. Should the organizers choose to cancel the conference and / or event and / or be instructed by any competent authority or governmental body cancel the the conference and / or event and following such instruction will be forced to cancel

them completely (this section refers only to cancellation of the conference and not to postponement of thereof), then the organizers shall promptly notify the participant.

- b. In such case, the organizers shall reimburse the participant for the payments received from him up to that date in their nominal value actual received and less the cost of the clearing fee and the registration fee.
- c. Beyond the refund of the participant's payments by the organizers, the participant will not have any demand and / or claim and / or claim from the organizers for the cancellation of the conference and / or the event.
